Summary of the Observations received since the last HACC Meeting – including our comments and Actions

(information provided by G Jarvis for inclusion with the agenda for the meeting on 25th April 2018)

In the 17 months (November 2016 – March 2018) since our last meeting, we have received 53 observations from 6 people, which is less than 0.45% of flights.

4 Observations were about the Air Ambulance, 2 of overflight both on their way out, which is something I feel we all need accept. The Crew are all aware of our Flight Protocol and ensure they avoid all sensitive areas when not responding to emergency. Two further observations were about their Night Flying. The Air Ambulance is now operational from 7:00am to 2:00am. They will be night Flying.

28 observations from one individual between November 2016 and May 2017 came in the main back to us from SSDC and contained photographic record of perceived overflight. I could not disprove 15 of them. All our based pilots and regular visitors were contacted by email and reminded to avoid the area when safe to do so and asked to keep GPS tracks of their movements. With only a further 5 overflights of the area since, I am hoping we have had a positive outcome.

Of the other 21 observations, 17 related to overflight, 14 of which were accepted – one Pilot has been asked not to use the Airfield in the future. All other pilots have been cautioned and none have repeated. Two were disproven with GPS tracks, one was an aircraft not using the field. One of these overflight observations questioned the noise limit of the aircraft, no information is available about the exact configuration.

Of the 4 further observations:

- One questioned use by a motor glider which doesn't contradict our consent.
- One questioned Helicopter circuit training. Helicopter pleasure flights were being conducted.
- One questioned use by a Texan, a large and quite noisy aircraft. This was an emergency divert as the runway at Yeovilton had been closed due to a wheels up landing.
- The fourth rightly questioned the Yak team exceeding the weekly maxima for aerobatic events. They have been told that this will not happen again.
